- 3. The Commission welcomed Mr. Rob Roddy, new owner of The Quarry (Restaurant). Mr. Roddy presented plans for improvements to the property, to include a stage, bathrooms,

golf tees with a floating green in the rock quarry lake, pickleball courts and an astroturf gathering area. There will also be parking for food trucks. This will be an exciting new venue for the New Melle area. Thank you, Mr. Roddy, for adding to New Melle a destination for a variety of possibilities.
