BILL #504 – ORDINANCE 489– AN ORDINANCE OF THE CITY OF NEW MELLE, MISSOURI, GRANTING A FRANCHISE AGREEMENT TO BRIGHTSPEED OF MISSOURI, LLC, F/K/A CENTURYTEL OF MISSOURI, LLC, ON BEHALF OF ITSEF AND ITS OPERATING AFFILIATES (BRIGHTSPEED) TO OPERATE AND MAINTAIN A TELECOMMUNICATIONS SYSTEM IN THE CITY OF NEW MELLE, MISSOURI

Alderman Karrenbrock made a motion to table Bill #504 Ordinance 489, seconded by Alderman Schneider. Motion passed unanimously.

ENGINEERING REPORT

- 1. The easement acquisitions for the Mill St./Peter Street Improvement Project are moving to finality. An Ordinance to move forward to begin construction on this project without all signatures will be introduced at the next Board of Aldermen meeting.
- 2. The Agreement between St. Charles County, Missouri and the City of New Melle for the use of St. Charles County Transportation Sales Tax Funds for Improvements to Foristell Rd. was reviewed. Alderman Karrenbrock made a motion to accept and sign the agreement, seconded by Alderman Goodman. Motion passed unanimously.

OLD BUSINESS

- 1. The city received three bids for replacing the damaged entrance ramp to city hall. The bids were reviewed by the Board of Aldermen. Alderman Karrenbrock made a motion to accept the bid from The Deck Shop, seconded by Alderman Schneider. Motion passed unanimously. City Clerk Gay will notify The Deck Shop that their bid was accepted.
- 2. Discussion regarding "R-3" Zoning is tabled until another time. Alderman Karrenbrock made a motion to have the Planning and Zoning Commission review and revise the Ordinance to present to the Board of Aldermen in a future meeting.

NEW BUSINESS

- 1. Review of Chapter 405 Zoning Ordinance, Article IX Prohibited Uses, Section 405.480 for storage trailers, trucks over (1) ton, boats and recreational vehicles or other recreational equipment, by the Board of Aldermen determined it should be revised. Alderman Karrenbrock made a motion to further review and revise the ordinance, seconded by Alderman Schneider. Motion passed unanimously.
- 2. It is also in the interest of the Board to hire a part-time Code Enforcement Officer to address the concerns of code violations within the City of New Melle.
