- 1. The Planning and Zoning Commission reviewed the proposed Bill 499, Ordinance 484; Title IV Land Use, Chapter 405 Zoning Ordinance, addition of classification "R-1E". A typo correction was made and the Commission approved the change to the Ordinance. Commissioner Duggan made a motion, Commissioner Sims seconded. All aye. Motion passed unanimously and recommended the Bill to move forward to the Board of Aldermen for approval.
- 2. The Commission reviewed the annexation procedures for the city of New Melle. The procedure validates the 15% contiguous with the existing city limit to be voluntarily annexed. Also brought forward was whether an Annexation Agreement with the City of O'Fallon should be considered. That item was tabled.
- 3. The Commission discussed the political sign regulations as noted in the ordinance. Some of the signs are out of compliance with the city regulations and also with State statutes. With the upcoming elections, an effort should be made to instruct the public of the size regulations and the Commission questioned if Federal or State statutes override the city regulations.
